I understand that coaching is NOT THERAPY/COUNSELING although clients may receive coaching in conjunction with therapy/counseling.

I understand that through our coaching classes we will be learning about HOW TO BE A CHRISTIAN LIFE COACH.

I understand that I am training with Dr. India and India's Christian Coaching Academy LLC.

I understand that Dr. India Logan, is not a medical doctor and thus not able to give medical (mental or physical) advice from a medical standpoint.

I understand that all coach training payments/services are non-refundable.

I understand I am responsible for connecting via tele-web conference for the live hours if I want live hours.

I understand that I will receive class materials and other information in my email.

I give Dr. India, India's Christian Coaching Academy LLC, and trainers permission to send me emails.

I understand that I will not give away or post any materials within the program.

I understand that I will not sell any materials within the program.

I understand that I am not permitted to photograph, screenshot, video record, audio record, and/or post/share any of the class material.

I understand that if I photograph, screenshot, video record, audio record, post or share the class material whether in person or online, I will be subject to legal action.

I understand that all course material is copyrighted and therefore protected by copyright laws.

I understand that I will be a certified Christian life coach upon completion of this program, assuming I meet the requirements as stated by this academy.

I understand that what we discuss during classes for live training ***may be recorded for training purposes and shared with future, current, and previously enrolled students.*** What I share during class will not be

reported, unless I indicate, in any way, that I would/will harm myself or others, then the proper authorities will be notified.

I understand that my instructor/mentor does not control the direction of my studies, career, and/or my life. Only God above and I do that.

I understand that my instructor's qualifications are as follows: Certified Life Coach Trainer.

I understand that Dr. India Logan and India's Christian Coaching Academy LLC is not responsible for my credentials, my ability to receive credentialing, or my ability to meet credentialing criteria under any credentialing organization.

I understand that as of this day listed on the contract, International Coaching Federation requires 60 amount of live training hours. India's Christian Coaching Academy LLC offers live training hours and Dr. India, and India's Christian Coaching Academy LLC is not responsible if International Coaching Federation does not count the live training hours from this academy, towards their credentialing process. The hours I train with this program **may or may not** count toward coach-specific hours that could be used when applying for any credentialing status to include ACC, PCC or MCC, through the International Coaching Federation.

I understand that the coach, coach trainer, instructing and training me, Dr. India, and India's Christian Coaching Academy LLC, is not responsible if the International Coaching Federation does not count the certification training hours towards their credentialing or changes the policy after the date listed on this contract. Receiving International Coaching Federation (ICF) credentials is contingent upon their acceptance and approval. I understand that I do not need ICF accrediting to coach or to run my own coaching business, unless otherwise stated by my government.

I understand that as of this date, as stated on my contract with India's Christian Coaching Academy LLC, this program, if taught live (in person or via tele-class) the hours may or may not count toward coach training hours when applying for credentialing with any other credentialing body. Dr. India and India's Christian Coaching Academy LLC is not responsible if a credentialing body does not count the certification training hours I gained with India's Christian Coaching Academy LLC or changes their policy after the date listed on this contract.

I understand that Dr. India and India's Christian Coaching Academy LLC is solely responsible for providing certification services and for Certifying me as a Christian Life Coach.

I understand that I do not need any accrediting or credentialing, Christian or not, to coach or to run my own coaching business, unless otherwise stated by my government.

This program, company and instructor can change their policies at any time.

Student Contract and Agreement Payments

All student payments are non-refundable. If you select a payment plan with Dr. India and India's Christian Coaching Academy LLC, or through a third-party servicer, all previously made payments, whether paid in full or towards a payment plan are final. We have a **no refund policy**.

Payment/s through Buy Now, Pay Later: Klarna, Affirm, Afterpay, and all other “buy now, pay later” Service Providers

If you decide to quit the academy, ask to be unenrolled, or end the program prematurely, you will not be refunded for all previously made payments. If you paid in full, you cannot be reimbursed.
